If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. 4. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in

support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1\\_4\\_2021\\_PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

10. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

## INSTRUCTIONS TO THE BIDDERS/TERMS & CONDITIONS

1) follows:- **ELIGIBILITY CRITERIA:-** The eligibility criteria for submission of bids for the work are as

- a) The bidder should be engaged in Calibration Services (Same or Similar service) for at least two years till publishing of this BID in Calibration of Medical Equipments and Instruments, in reputed government/private hospitals. Attested copy of necessary certificate should be enclosed.
- b) The bidder firm (Calibration Laboratory) should be a NABL certified testing Laboratory with best measurement quality having facility of all of mechanical, thermal, electrical, viscosity & density measurement.
- c) Photocopy of valid current Authorization certificate from NABL along with certificate of Excellence (if any) should also be submitted.
- d) The firm should be responsible if any mishap take place on account of nonconformities of safety standard and rules on their part.
- e) Test equipments used for calibration should be of NABH / NABL/ISO standard.
- f) The equipments should be calibrated at our site and at the same location.
- g) Calibration report should be submitted within 15 days of completion of work.
- h) No damage to any of the equipments/instruments shall be caused during/out of the calibration process. If any damage occurs, the service provider shall be responsible for the repair / replacement of the same to the satisfaction of the competent authority at their own risk and cost. The decision of the Medical Superintendent ESIC Hospital, C.B Ganj Bareilly in such cases will be final and binding to the bidder.
- i) The bidder should submit document showing scope of services.
- j) Validity of Calibration certificate should be at least for 1year/ or as per Guidelines.

2) **Average annual turnover of the bidder** in last two financial years' i.e. 2023-24 and 2024-25 should be a minimum of Rs 2 Lacks in each year.

3) Scanned Self attested copies of the following documents shall be uploaded along with the Technical Bid:-

- i) **Average annual turnover Certificate of the bidder** in last two financial years' i.e. 2023-24 and 2024-25.
- ii) **Satisfactory work completion certificates** (Annexure-E) from clients in support of the work experience showing the period and value of contract executed.
- iii) **An Undertaking / Declaration** by the bidder (Annexure C) that,
  - a) It has **not been blacklisted** from providing the services of manpower/operational services, earlier by any Central Govt./State Govt./P.S.U.
  - b) It has all **statutory registrations/licenses** for execution of the work.
  - c) It has **executed all its contracts satisfactorily** during the past one year and its contracts have neither been terminated nor any extension of its contracts been denied by any Central Govt./State Govt./P.S.U. on the grounds of unsatisfactory performance.
- 4) The scanned copy of duly signed declaration shall be uploaded along with the Technical Bid.

5) Bids received online will only be considered and any bid/document submitted in hard copy shall not be considered.

6) Bidder has to provide calibration of working equipments/Instruments as per institutional requirements or as per manual of equipment/ instrument during the validity of Contract.

7) The bidder is expected to work out rates, keeping in view the technical specifications and terms & conditions of the contract and then arrive at the rates to be quoted.

8) The Bidder shall be deemed to have satisfied himself/herself before bidding as to the correctness and sufficiency of the rates to cover all its obligations under the contract and all matters and things necessary for proper fulfillment of the obligations under the contract. Also please note that no prices should be indicated in the technical bid or any other document to the than financial bid document Else the bid will be out rightly rejected.

9) The Bidder shall submit the Bid, which satisfies each and every condition laid down in the BID

Document, failing which the bid shall be summarily rejected. Conditional Bids will be rejected outright.

10) Corrupt or Fraudulent Practices: - The Medical Superintendent requires that the Bidders under this Bid observe the highest standards of ethics during the tender process and execution of this contracts. The Medical Superintendent reserves the right to reject a proposal for award, if it found that the Bidder recommended for award has engaged in any corrupt to fraudulent practice in competing for the Contract. The Medical Superintendent may deem a bidder ineligible, either indefinitely or for a stated period of time, to be awarded any contract if it at anytime it determines that the bidder has engaged incorrupt and fraudulent practices in competing for, or in executing a contract.

11) The bidders are advised to visit/inspect the site on any working day for assessing the extent and conditions of work and for collection of the information that may be required for preparing their bids and entering into a contract for the services to be rendered.

12) The bid shall be valid for 180 days from the date of opening.

13) The bidder shall quote for all items of work failing which the bid shall be considered as non-responsive. Incomplete or conditional bids will be rejected summarily.

14) In case the bid opening date is declared public holiday, bids shall be opened at the same time on the next working day.

15) The successful bidder will be required to execute an agreement on Non-Judicial stamp paper of Rs.100/- (to be purchased by the successful bidder) within two weeks from the date of receipt of letter of award unless extended by the Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly up to a maximum of another two weeks. EMD shall be forfeited if the successful bidder refuses or fails to execute the contract or fails to deposit the performance security deposit within the time frame specified i.e. within a fortnight to award of contract which can be extended by the Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly up to a maximum of further two weeks on the written request of the successful bidder.

16) The terms and conditions contained in the tender document shall form part of the agreement unless specifically modified/dropped and therefore, each page of bid document must be signed and stamped by the authorized representative of bidder in acceptance of the terms and conditions laid down.

17) The Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly reserves the right to withdraw / relax any of the terms and conditions of the Bid. The Competent Authority also reserves the right to reject all or any bid in whole, or in part, without assigning any reason thereof.

18) Financial Bid Evaluation Criteria: - The successful bid (L-1) shall be determined on the least cost basis.

19) The ESIC shall not be liable for / in respect of any damages / compensation payable to any workman for death/injury resulting from any act/default of the contractor. The contractor shall indemnify and keep indemnified the ESIC Hospital C.B Ganj Bareilly against all such damages compensations and expenses whatsoever in respect thereof or in relation thereto.

20) SUBLETTING OF CONTRACT: The contractor or shall not sublet, transfer or assign the contractor any part thereof. In the event of the contractor contravening this condition the Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly will be entitled to place the contract elsewhere on the contractors account at his risk and costs. Besides the contractor shall be liable for any loss or damage which the Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly may sustain in consequence of arising out of such replacing of the contract.

21) ARBITRATION CLAUSE: In the event of any question, dispute or difference arising under these conditions or any other conditions of the contractor in connection with this contract, except as to any matter the decision of which is specially provided for by these on the special conditions the same shall be referred to the sole arbitration of the Medical Superintendent ESIC Hospital, C.B Ganj Bareilly or any person appointed by him.

22) **INDEMNITY CLAUSE:** The contractor or shall ensure full compliance with tax clause and Labor laws of India with regard to this contract and shall be solely responsible for the same. The contractor or shall fully indemnify against any liability of the levies/taxes, interest, penalty etc. by any statutory Authority against act of omission of the contractor in connection with execution of the contract.

23) **PAYMENT PROCEDURE:** No advance payment will be given to the contractor. GST shall be payable at the prevailing rates and the contractor shall deposit the same. Tax Deduction at Source shall be made as per prevailing tax laws. Payment for calibration services will be paid within 30 days after successful completion of work and submission of valid reports and GST invoice.

24) **FALL CLAUSE:** The contractor or shall undertake that he has not supplied / Is not supplying the similar items / services at a price lower than that offered in the present bid in respect of any other hospital / institution of the Government of India or autonomous body and if it is found at any stage that the item/service was supplied by the Bidder to any other hospital/institution of the Government of India or autonomous body at a lower price, then that very price will be applicable to the present case and the difference in the cost would be refunded by the contractor and if the contract has already been concluded, the same shall also be recoverable by the way of deduction from any amount payable to the contractor.

25) **RECOVERY OF SUMS DUE:** Whenever any claim for payment of any sum of money arises out of or under the contract against the contractor or, the Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly shall be entitled to recover such sum by appropriation in part of whole of performance Security Deposit by the contractor. Should the sum not be sufficient to cover the full amount recoverable, the contractor should pay on demand the remaining balance due.

26) **INSOLVENCY AND BREACH OF CONTRACT:** The Medical Superintendent, ESIC Hospital, C.B Ganj Bareilly may at any time terminate the contract without any compensation in the following events:

- a. The contractor / firm / any partner be at any time adjudged insolvent.
- b. If the contractor commits any breach of the contract not specifically provided without prejudice to remedy.

## 27. Term and Extension Clause:-

### 1. Term of Agreement:

After the award of the contract, the Agreement shall remain in force for an initial period of one (1) year commencing from the Effective Date, unless earlier terminated in accordance with the terms of the Bid.

### 2. Extension:

Upon the expiration of the initial term, the contract may be extended for an additional one (1) year period, subject to the satisfactory performance of the Service Provider.




